GENERAL INFORMATION

BOWL GAME™ Blue Liquid pond dye is a highly concentrated colorant that is non-toxic and creates a beautiful natural appearance for any lake, pond or fountain. **BOWL GAME™ Blue Liquid** pond dye is safe for fish and aquatic species, waterfowl, wildlife and pets. It is a non-corrosive dye and when used according to recommended rates will not stain stone, fountains, aquatic features or swimwear.

- Enhances the natural beauty of any body of water with a natural reflective surface
- Obscures visibility into the water
- Reduces sunlight penetration

The dye will stain rocks, decking and other porous surfaces if spilled or applied as a concentrate. Do not use in water that is expected to be consumed by humans.

DIRECTIONS FOR USE

Pour the appropriate amount of dye into the water along the edge of the lake or pond. **BOWL GAMETM Blue Liquid** will distribute evenly, dispersing with lake and pond currents, and wind-blown water movement. To assist diffusion throughout the entire lake or pond, empty the gallon container(s) at different points around the lake or pond edge, or through an aerator, circulation or injection system, waterfall or fountain. Wear eye protection and rubber gloves, carefully applying the dye directly to the water.

BOWL GAME™ Blue Liquid is a high-quality, aquatic dye that will be degraded by chlorine, which will diminish the lake or pond coloration.

In non-chlorinated systems or lakes and ponds, dye is broken down gradually through biological and photo-degradation. Coloration is also reduced through the natural process of dilution (i.e. – addition of fresh water to the lake or pond). The original color level should be stable for 2-4 weeks, depending on your lake or pond system. Chlorinated systems typically require dye addition within 2 weeks, while biological and photo-degradation is common within 4 weeks. To

return your beautiful lake or pond color to its intended coloration level, simply add small amounts of **BOWL GAME™ Blue Liquid** from time to time which will offset the natural color loss.

USE RATES

BOWL GAME™ Blue Liquid should be applied one (1) gallon of dye per acre of water with an average water depth of four (4) feet (4 acre-feet).

One (1) ounce treats approximately (8500) gallons of water for small ponds.

An acre/foot of water can be determined using the following formula:

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. To avoid product degradation and equipment corrosion, do not use iron, copper or aluminum containers or equipment. Material is hygroscopic and should not be exposed to moisture in order to maintain product integrity. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
