GENERAL INFORMATION

COMPLETION™ is a highly effective water conditioning agent designed to be compatible with most pesticides. **COMPLETION™** contains ammonium sulfate which is well proven as an uptake enhancer in herbicide tank mixes at the standard use rate. It is recommended that **COMPLETION™** be used wherever a pest control product recommends the use of ammonium sulfate or where hard water is a concern for active ingredient performance.

- Minimizes antagonistic interaction between hard water ions and active pesticide ingredients
 - Improves efficacy of tank mix actives
- Use as a replacement for dry or liquid AMS
 - Proven to work at lower use rates
- Easier to handle, transport and store than dry AMS
 - Blends quickly for reduced mixing and loading times
 - No heavy bags that are sensitive to humid storage conditions
- Lowers pH of tank mix
 - Reduces alkaline hydrolysis of pesticides sensitive to high pH

DIRECTIONS FOR USE

NOT FOR AQUATIC USE

COMPLETION™ does not contain oil or surfactant but may be used in conjunction with these products. Use only with pesticides that allow low pH conditions. Do not use with copper-containing actives.

Follow the mixing procedure for the pesticide being used. While **COMPLETION™** may be added at any time, it should be added after any wettable powders or other solid formulations have been thoroughly dispersed, for maximum efficacy and ease of dispersion.

At the highest use rates, **COMPLETION™** has been shown to work as well as 8 1/2 pounds of dry ammonium sulfate per 100 gallons of water in glyphosate tank mixes.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.
