## FIRST AID

#### **GENERAL INFORMATION**

**GREEN-DURA** is a persistent, UV resistant colorant and spray pattern indicator recommended for use on sports fields, turf and sod farms. May be applied to growing or non-growing grass.

**GREEN-DURA** rapidly revitalizes the appearance of off-color turf without the cost of over seeding during the dormant season.

GREEN-DURA may be used to color divot sand and as a spray pattern indicator.

**GREEN-DURA** is the professional's choice for high impact sports turf where player uniform staining is a concern.

#### **DIRECTIONS FOR USE**

Caution should be used when applying this or any other product on turf.

The use of teflon seals to aid in the prevention of leaks when using **GREEN-DURA** colorant in centrifugal pumps is recommended.

Standard ceramic seals may leak during operation.

Mow turf if necessary before applying.

Do not spray to run-off. For best results, use a flat fan nozzle with fine particle size.

Spot test for acceptable color depth prior to full scale spraying. Retain mix rate records as a reference tool for future spray applications.

Avoid over-spray where not desired such as concrete, hardscaping and other areas. Staining will occur.

Immediately rinse accidental over-spray areas with water prior to drying.

Though phytotoxicity has been evaluated, care should be taken by conducting a jar test or testing this product on sensitive plants before full application is performed.

#### **EQUIPMENT CLEAN-UP:**

After spraying, fully rinse tank and ensure that all lines, filters, and nozzles are clear of mix.

#### DO NOT ALLOW TO MIX TO STAY IN TANK OR LINES OVERNIGHT.

Prior to mixing, fill the spray tank with half of the carrier. Start the sprayer and check to make sure that all valves and gauges work and that there is adequate tank agitation.

For best results, apply to dry turf when the temperature is above 40°.

Allow the application to dry fully before re-entry.

#### **APPLICATION RATES**

#### **Turf & Sports Fields**

For non-dormant turf: Use rates begin at 2.5 gallons (9.46 liters) colorant to 50 gallons (190 liters) water per acre

For dormant turf: Use 5 gallons (18.93 liters) colorant to 50 gallons (190 liters) water per acre.

**Divot Sand:** Mix 8 ounces (237 mL) of colorant to 8 ounces (237 mL) of water for every 100 pounds (45 kg) sand.

2 applications may necessary for desired coverage. Longer and fuller grass may require the higher rate of **GREEN-DURA**. Adjust rates as needed.

#### STORAGE AND DISPOSAL

Storage: DO NOT FREEZE! Limited shelf life. Shake well before using. Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

Disposal: Do not contaminate water, food or feed by disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national and international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
