### PRECAUTIONARY STATEMENT

## GENERAL INFORMATION

**HAND OFF™** is a high quality adjuvant designed to augment the performance of systemic and contact fungicides while it extends disease control. **HAND OFF™** provides superior spray coverage and deposition characteristics. It assists the fungicide in sticking to the leaf surface where it provides optimal control.

- Superior emulsion of tank mix partners
  - Disburses fungicide actives throughout the spray
- Lower surface tension of tank mix allows spray droplets to spread upon contact
  - Increased contact area ensures contact fungicides protect more of the plant surface
  - Allows water to penetrate plant surfaces, aiding delivery of systemic fungicide actives
- Includes humectants to slow drying time
  - Slows drying time for extended contact protection and increased systemic uptake

## DIRECTIONS FOR USE

### NOT FOR AQUATIC USE

**HAND OFF™** is designed for use with fungicides registered for use on all golf courses, sports, residential and commercial lawns and other turf applications.

## MIXING INSTRUCTIONS

Always follow the instructions on the pesticide label. If the label lacks specific mixing instructions, fill the spray tank 3/4 full of target water volume. Begin agitation.

Add tank mix ingredients in the following order:

1. Ammonium sulfate, fertilizers and micronutrients
2. Water-soluble packets, dry flowable and dispersible granule pesticide formulations
3. Flowable pesticides
4. Water-soluble pesticides

5. Emulsifiable concentrate pesticides
6. If foaming occurs, use an antifoam product such as REVERSE™
7. Maintain agitation and finish filling spray tank to desired level
8. Add **HAND OFF™** to the tank and agitate until thoroughly mixed
9. Continue agitation as necessary to maintain mixture and an even application of the active

## USE RATES

Mix **HAND OFF™** at the following rate of adjuvant per total amount of solution:

1 pint (16 fluid ounces) per 100 gallons ½ oz. per 3 gallons

125 milliliters per 100 liters

5 milliliters per 4 liters

0.125% volume/volume

## STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.
