FIRST AID

GENERAL INFORMATION

HASHMARK[™] Blue Liquid HC is a user-friendly, water soluble, nonstaining concentrated marking dye for use in spray applications.

HASHMARK[™] Blue Liquid HC indicates where a mixture has been applied and helps to avoid over-spraying and skipped areas.

Can be used with all application equipment and is recommended in all crop and non-crop areas including aquatic, industrial vegetation management (IVM), forestry, foam marking, turf and ornamental.

DIRECTIONS FOR USE

Follow the recommendations of the most restrictive active ingredient label.

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

Application rates of **HASHMARK[™] Blue Liquid HC** may need to be adjusted to increase color intensity depending on environmental conditions, tank mix partners and their use rates.

Recommended use rate: 5-10 ounces per 100 gallons (160-310 milliliters in 400 liters).

Use rate for small sprayer applications: ½ to ½ ounce (approximately 1-2 teaspoons) per gallon (5-10 milliliters per 4 liters).

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. Store above 55 degrees F (13 degrees C). If temperature drops below 55degrees F (13 degrees C), warm above that temperature, then shake well.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local /regional/national/international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
