If skin irritation occurs: Get medical advice or attention.

**IF SWALLOWED:** Unless advised otherwise by a poison control center or doctor, have person rinse mouth with water, if able. Do not give anything by mouth to an unconscious person. Call a poison center, doctor, chemical manufacturer, importer, or distributor to specify the appropriate source of emergency medical advice if you feel unwell.

**IF INHALED:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

## GENERAL INFORMATION

**PLAY OFF™** is a concentrated fragrance designed to mask objectionable chemical odors. The offensive odors associated with the application of some herbicides, insecticides and fungicides can be particularly unpleasant. Adding **PLAY OFF™** to the tank mix will minimize the detection of these chemical odors.

- Will not affect chemical efficacy of active ingredients
- Will not injure sensitive turf, ornamentals or other plants

## DIRECTIONS FOR USE

Add 1 to 3 ounces of **PLAY OFF™**, per gallon of chemical, or 4 pounds of wettable powder with objectionable odor.

Odor intensity will vary with different chemicals. Start by adding 1 ounce per gallon, and slowly increase to obtain desired effect.

## STORAGE AND DISPOSAL

**STORAGE:** Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

**DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
