FIRST AID

Have the product container with you when calling a poison control center or doctor, or going for treatment.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do then continue rinsing.

GENERAL INFORMATION

AquiMax® Breakwater is a premium, 100% functioning agent soil moisture management system that enables precipitation and irrigation to penetrate into wetting resistant soils almost immediately.

Regular use helps to reduce irrigation erosion and begins to rehabilitate poor draining, compacted soils.

AquiMax® Breakwater is recommended for use with all irrigation systems (except earthen dams) in agricultural applications. May be used with fertilizer and nutrient solutions if compatibility is confirmed with a jar test.

DIRECTIONS FOR USE

Apply **AquiMax® Breakwater** early or at any time during the growing season.

AquiMax® Breakwater is a soil water management system and is NOT effective on foliage.

Treatment must be immediately followed with a minimum ¼ inch of water to ensure soil contact.

Jar test when combining with nutrients or fertilizers: Partially fill a con-

tainer 2/3 full of the water to be used in the sprayer solution. Using the correct dilution, add all the tank mix components and fill the jar with water. After shaking the container vigorously, compatibility can be determined by observing any precipitates or separation.

APPLICATION RATES

Calibrate the flow rate prior to application according to the equipment manufacturer's directions or through visual flow. Adjust variable speed pump to proper flow rate.

AquiMax® Breakwater may be delivered via pivot, linear, sprinkler or drip tape systems.

First application: 1 quart per acre.

Second and subsequent applications: 1 pint per acre

Follow with water to wash the active ingredients from the leaf surface and into the soil and root zone.

Applications can also be made as needed throughout the season to relieve plant stress caused by hydrophobic soils.

STORAGE AND DISPOSAL

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

Disposal: Do not contaminate water, food or feed by disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national and international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
