GENERAL INFORMATION

DELINEATE™ is a tough, flexible foam marker formulated to tolerate most weather conditions.

DELINEATE includes components that allow the product to perform in practically any water. **DELINEATE** will make a firm, dense foam that persists 30 minutes or more.

DIRECTIONS FOR USE

Follow the equipment manufacturer's instructions if available.

For best performance, **DELINEATE** should be used with marking equipment that has been cleaned and maintained according to the manufacturer's instructions. Air intake filters, tank screens and hoses should be checked periodically to ensure sufficient air and liquid flow.

USE RATES

2 pints **DELINEATE** per 25 gallons of water

Add water to the foam marker tank and then add **DELINEATE**. Mix according to equipment manufacturer guidelines.

If foam is runny or watery, put in additional **DELINEATE** until preferred texture and stability are attained. If foam is too thick, add water.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not contaminate water, food or feed by storage or disposal of this product. **STORE BETWEEN 40° AND 90° F.**

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law.
