If skin irritation occurs: Get medical advice or attention.

IF SWALLOWED: Unless advised otherwise by a poison control center or doctor, have person rinse mouth with water, if able. Do not give anything by mouth to an unconscious person. Call a poison center, doctor, chemical manufacturer, importer, or distributor to specify the appropriate source of emergency medical advice if you feel unwell. DO NOT INDUCE VOMITING.

IF INHALED: If experiencing respiratory symptoms: Call a poison center, doctor or physician. If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

GENERAL INFORMATION

HASH MARK™ Green Liquid marker dyes are highly concentrated colorants specifically designed to help identify pesticide or fertilizer spray application patterns. When applying solutions containing **HASH MARK™ Green Liquid**, an applicator can visually confirm the quality of the spray application and eliminate costly mistakes caused by skips and overlaps. **HASH MARK™ Green Liquid** is formulated using dyes that are safe for the environment.

DIRECTIONS FOR USE

In order to determine the best application rate, experiment with the volumes and addition rates of **HASH MARK™ Green Liquid** to find the optimal rate. Start with a rate of 3/4 - 1.5 ounce per 10 gallons or about 1/2 - 1 teaspoon per gallon of spray solution. Rates will vary depending on turf color, turf height, and spray application rate.

Note: The recommended concentration of **HASH MARK™ Green Liquid** may be changed according to the needs of the operations being performed. Higher dosage rates will increase the intensity of the color once it is applied.

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
