Lateral™ G is a granular wetting agent that improves moisture uniformity and wetting of hydrophobic soils. Lateral G is effective for prevention and remediation of Localized Dry Spot (LDS). Lateral G can be used to reduce hydrophobicity on golf courses, roughs, fairways

and approaches, sod farms, athletic fields, and home lawns, and is also recommended for soil water management when planting ornamentals or to follow a hydroseeding operation.

DIRECTIONS FOR USE

The first application of **Lateral G** should be applied at 2.5 - 5 pounds per 1000 square feet.

Re-apply every 30 days or as needed to prevent yellowing/browning symptoms from re-appearing.

STORAGE AND DISPOSAL

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. Store between 40° and 90° F.
