FIRST AID

GENERAL INFORMATION

Dry, granular **AquiMax® Turf Pro G** is an easy-to-handle, advanced soil wetting and moisture retaining technology that helps water to penetrate into hydrophobic soil layers and remain in the zone where plant roots are actively growing. **AquiMax Turf Pro G** is useful for treating localized dry spot (LDS) and other conditions of wetting resistance in intensively managed turf.

DIRECTIONS FOR USE

Before applying **AquiMax Turf Pro G**, calibrate application equipment and test spread pattern to ensure consistent coverage.

Use a spreader or hand apply to the desired area. After application, immediately hand water or irrigate with 1 inches of water to release **AquiMax Turf Pro G** into the soil structure.

Though phytotoxicity has been evaluated, care should be taken by testing this product on sensitive plants before full application is performed.

USE RATE

Apply 2.5 to 5 pounds of **AquiMax Turf Pro G** per 1000 square feet every 4 to 6 weeks. Increase application frequency if signs of stress appear before the reapplication date has been reached.

After application, immediately hand water or irrigate with 0.5 to 1 inches of water to release **AquiMax Turf Pro G** into the soil structure.

HANDLING, STORAGE AND DISPOSAL

Handling: Spills will be slippery and adding water to spills will increase slipperiness. Treat spills with absorbent material. When absorbent material is disposed of, rinse area thoroughly until slipperiness disappears.

Storage: Keep bags closed at all times. Store in a cool, dry place.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
