PRECAUTIONARY STATEMENTS

Causes serious eye irritation. Harmful in contact with skin. Harmful if inhaled. Avoid using product in a manner as to directly, or through drift, expose workers or other persons. Applicators and other handlers must wear goggles or a facial splash shield; chemical resistant gloves such as nitrile rubber ≥ 14 mils or neoprene rubber ≥ 14 mils; coveralls or long-sleeved shirt and long pants; shoes plus socks and mist-filtering respirator. Wash the outside of gloves before removing. Remove protective and other contaminated clothing and equipment after handling and wash it before reuse. Wash thoroughly and change into clean clothing.

FIRST AID

IF IN EYES: Immediately wash eyes with large amounts of water for at least 15 minutes, lifting the lower and upper lids. Remove contact lenses if present and continue rinsing. If irritation persists, seek medical attention IMMEDIATELY.

IF ON SKIN OR CLOTHING: Remove contaminated clothing and immediately wash contaminated area with large amounts of water for at least 15 minutes. Call a poison center or doctor if you feel unwell.

IF SWALLOWED: If person is conscious, immediately give large quantities of water and induce vomiting.
