Convey is a premium nonionic surfactant (NIS) specifically designed to enhance plant growth regulator (PGR), fungicide applications and other active ingredients that adjust crop development, flowering, and harvest date.

- Formulated to use with actives that are applied to growing, often young, crop plant tissues.
- Surfactant chemistry without the detergent stripping of surface waxes that is commonly used for herbicides that are intended to assist in weed burndown.
- May also be applied with insecticides.
- Less harsh on the foliage of multi season or long days-to-harvest crops.

Convey is biofriendly and easy to use:

- Enables the lowest label-recommended use rate of the active ingredient to be applied.
- Superior spreader and wetter that promotes uniform coverage with plant growth regulators that **MUST** be uniformly applied to be effective.
- Can be used with growth regulators and fungicides such as streptomycin that are often applied simultaneously.

HOW TO USE

Follow the recommendations of the most restrictive active ingredient label.

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

Use only if a nonionic surfactant is allowed or not excluded on the label.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety

Convey does not contain ammonium sulfate.

RECOMMENDED USE RATES

General Use Rate

Use 1 to 3 pints of **Convey** per 100 gallons of spray solution.

Add the nonionic surfactant (NIS) at this use rate recommended on the active ingredient label or use the chart below when no specific rate is listed:

Application:	pints per 100 gallons	mL per 100 liters
Apogee®	1 to 2	125 to 250
Ethephon, Ethrel	2	250
Maleic Hydrazide	2 to 3	250 to 375
NAA or Amide Sprays	2 to 3	85
NAA plus Carbaryl	1 to 2	65
NAD	1	125
Streptomycin	1 to 2	125 to 250
