GENERAL INFORMATION

HASH MARK™ Blue Liquid is an easy-to-use, general purpose colorant formulated to increase the visibility of spray applications. Tinting the application solution makes pattern inconsistencies easier to observe and correct.

HASH MARK™ Blue Liquid is compatible with most active ingredients and fades with normal weathering.

DIRECTIONS FOR USE

Follow the recommendations of the most restrictive active ingredient label.

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

If the active ingredient label does not specify the use of a colorant, follow the directions below. Use only if a colorant is allowed or not excluded on the label.

HASH MARK™ Blue Liquid does not contain ammonium sulfate.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety.

Order of addition

Prior to mixing you should fill your spray tank with half of the carrier that you intend to use. Then start the sprayer and check to make sure that all valves and gauges work and that you have proper tank agitation.

In general, follow the W-A-L-E-S plan when adding herbicides to a tank mix.

1. Wettable Powders (WP) then Flowables (F, DF)
2. Agitate then add anti-foaming compounds, buffers
3. Liquid and Soluble products
4. Emulsifiable concentrates (EC)
5. **HASH MARK™ Blue Liquid** and other adjuvants

USE RATES

Begin with ½ to 1 ounce of **HASH MARK™ Blue Liquid** for each gallon of solution and increase the amount gradually if a more intense color is needed for specific field conditions.

STORAGE AND DISPOSAL

DO NOT FREEZE

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
